### Overnight Behavioural Counsellor – Part Time

#### RESPONSIBILITIES

Under the supervision of the Clinical Supervisor- Residential Services, the Overnight Part-Time Behavioural Counsellor will work Friday, Saturday and Sunday overnight at Dougan, Morrow or Century.

The scope of duties includes the following:

- Monitor the treatment centre during overnight hours
- Interact with residents consistent with individual treatment needs and treatment plans
- Perform light housekeeping chores including laundry, clean staff offices, etc.
- Perform mandatory hourly resident bed checks
- Facilitate crisis intervention and supportive counseling/containment
- Make referrals to internal and/or external programs or services, as appropriate
- Attend all mandatory training programs and monthly team meetings
- Complete required documentation such as the Communication Log, program notes and Incident Reports
- Liaise and support full-time staff
- Prepare for and attend regularly scheduled clinical supervisions

#### COMPETENCIES

- Excellent communication and interpersonal skills
- Must be an excellent team player punctual, reliable and mature
- Must be able to work independently with minimal supervision
- Excellent organizational skills
- Excellent containment and crisis intervention skills
- Excellent time management and organizational skills
- Ability to function well within a fast-paced environment
- Proficient in computer skills including emails and Microsoft Office Suite
- Ability to be a role model to the residents within the Therapeutic Community treatment model

#### QUALIFICATIONS

- Completion of or enrollment in a Post-Secondary program relating to Social Services (College Diploma or University Degree)
- Previous experience in the field of addictions and residential treatment preferred

#### OTHER REQUIREMENTS

- Valid G Driver's License for a minimum of 3 years
- Satisfactory Motor Vehicle Record
- CSC Clearance conducted by PWGS Canada
- Standard First Aid/CPR Level C
- Must have access to own/reliable transportation – not on a bus route
- Must be able to attend work (travel to Residential Centres) within an hour of notification, when on call

- Stay-awake position requiring Overnight Part-Time Behavioural Counsellor to stay awake throughout the entire shift
