Addiction Counselling & Community Justice

NEW PROGRAM SPOTLIGHT

The Addiction Counselling & Community Justice program provides one stop support for folks currently on probation or parole to meet their reporting obligations, and to receive addiction counselling at the same place and time.

Nurse Practitioner Team

NEW IN 2021

Stonehenge's team of Nurse Practitioners (NP) work out of our RAAM clinics and Grand River Hospital's Withdrawal Management Centre.

Our NP's specialize in addiction medicine and work to improve health equity and access to medical substance use care.



Our Beneficiaries

The people we serve are the driver for everything we do at STC. We have a continual focus on ensuring that we meet the needs of our clients by improving accessibility, filling gaps in services, and continuously striving to ensure health equity for individuals who use substances.



Housing is a both a human right and a social determinant of health. When we can stabilize housing for individuals, we promote a person's wellness so they can stay focused on their health goals.

Over 70%

of housing clients said they had received the kind of support they needed in working toward their change and recovery goals.

Over 85%

said Supportive Addiction and Mental Health Housing (SAMH) has helped them have a safe and stable place to live, focus on self-care, and make healthier and safer choices about substance use.

100%

of transitional housing clients said SAMH has made them feel more hopeful for the future.

Residential Treatment Preparation Program

RTPP provides counselling and support to help prepare individuals who are on the waitlist for residential treatment at Stonehenge. The goal of RTPP is to support individuals who are contemplating or preparing for treatment, and help get clients ready to take action on their substance use concerns.

Program participants said the most helpful parts of the RTPP were: receiving feedback from peers and staff, learning about STC through those already in the program and reducing anxiety around entering residential treatment.

Rapid Access Addiction Medicine (RAAM)
